Reinventing Medicaid 2015: Home Stabilization Initiative

As part of Governor Gina Raimondo's effort to reform Medicaid, the Working Group to Reinvent Medicaid issued an April report that recommended numerous initiatives to achieve financial savings in State Fiscal Year 2016. The Governor introduced those recommendations in a budget article entitled, "The Reinventing Medicaid Act of 2015." The Rhode Island General Assembly passed the Reinventing Medicaid Act in June.

As a result of the Act's passage, EOHHS is seeking federal authority to implement several changes to the Medicaid program. This Category II request will implement a set of tenancy support services. These services are designed to encourage independence among Medicaid beneficiaries and provide them with the skills to be successful tenants. The goal is to improve health outcomes, reduce costs, and promote stability among vulnerable populations.

Notice is hereby given in accordance with the provisions of Chapter 42-35 of the Rhode Island General Laws, as amended, that the Secretary will hold a Public Hearing on the above mentioned matter on **Friday, November 13, 2015 at 10:00 a.m.** at which time and place all persons interested therein will be heard.
